Environmental awareness & recyclability

As a medium-sized company in the packaging industry, we have set ourselves the goal of protecting the environment in all operational processes. Of course, we comply with all applicable environmental regulations.

As part of our environmental policy, we have already successfully implemented the following points in our company:

- Use of environmentally friendly materials such as paper, glue (based on potato and cornstarch)
- The paper for sack production is only purchased from companies that pay attention to sustainable forestry
- Optimal production planning to save resources
- Optimization of tours to achieve a reduction in fuel consumption (continuous control and analysis of fuel consumption), avoidance of empty runs
- Development of the vehicle fleet with regard to new and fuel-efficient engines
- Use of reusable pallets to avoid unnecessary waste
- Own electricity production through a solar system on our hall roof

Another important point of our environmental policy is recycling. We not only pay attention to waste separation and recycling in our own premises, the recyclability of our products is very important to us.

We participate in the paper-recycling program of Interzero GmbH & Co.KG (formerly REPA) and can print our return-number on the paper sacks, at the customer's request, and thus feed them into the secondary cycle.

Our plastic bags are also ideal for recycling. These are remelted after use and can be returned to the secondary cycle as regenerated plastic. Our suppliers confirm a recyclability of 100%.

We strive for a continuous process to improve the protection of the environment. In the event of any innovations and changes to process flows in favor of environmental protection, our employees are informed and, if necessary, trained to guarantee correct implementation.
